The development, harmoniously integrated into its alpine environment, is located on the sunny slopes of Notre-Dame-de-Bellecombe, 10 minutes from Les Saisies and 25 minutes from Megève.

LES CHALETS KIORA, with direct access to the snow front, consists of 4 units plus an individual chalet of

generous proportions. Depending on their orientation, the units enjoy panoramic views of the ski area or the surrounding forest. Most of the resort's slopes converge on the Mont Rond sector, where the residence is located, allowing you to take a break at any time before putting on your skis again.

Part of the programme (33 flats from 2 to 5 rooms) is accessible as a classic residence.

The other 77 flats - from 2 to 6 rooms - are delivered fully equipped and decorated as they are intended for tourist accommodation.
