This rare century-old Historical property with an old hotel and spas is located in the heart of one of the most preserved French regions, 45 minutes from Vichy, 1.5 hours to Lyon and 3 hours to Geneva.

A Centennial Site at the Dawn of a Historical Renaissance

The Estate is located in the heart of an 18-hectare natural park and consists of:

- 6 thermal and mineral water sources
- an old thermal establishment composed of several treatment rooms, private lounges and bedrooms, and an astonishing indoor thermal swimming pool.
- a large, prestigious hotel with 40 rooms with outbuildings
- an old gaming casino to be rehabilitated
- a wooded park with a tennis court, and various walks
- a modern, automated and operating bottling plant

The bottling plant in operation

The natural waters of the area come from thousand-year-old meteoric precipitation that fell 4000 years ago. After a centuries-old journey in the granite rock, they spring naturally onto the Domaine at an average temperature of 27 degrees.

Created in 1997, the factory was completely renovated and modernised by the previous buyers in 2006, notably with the installation of a bottling line for glass bottles.

There's a functional and operational production tool today, but certain investments remain necessary.

A mineral water, it is recognised as being of public utility by the Academy of Medicine in 1848. Today, only one of the 6 sources is exploited, connected directly to the bottling plant.

A century-old thermal establishment to be rehabilitated

In operation since the Gallo-Roman era, the thermal establishment was created in the 19th century. It is made up of several treatment rooms, lounges, private rooms, and an astonishing indoor thermal swimming pool.

Exceptional Hotel potential

- The park includes a former large prestigious hotel with a restaurant room of more than 100 sqm, 3 private lounges and around forty rooms.
- A building with studios and staff quarters
- A gaming casino completed the leisure offerings intended for spa guests.

The property is being offered for 10M, and it is estimated the work will be at least double that amount. This project is not suitable for everyone and not for private individuals.




