This chateau is situated in the Indre department, in the heart of George Sand country, in the Centre-Val de Loire region. The fortress was built at the end of the 12th century and is listed as a Historic Monument.

The property spans over approximately 2.3 hectares of enclosed parkland. The château itself has around 1,400 sqm of living space and is comprised of 22 main rooms including lounges, reception rooms, a library, offices, 9 bedrooms, and numerous bathrooms.

The property has been fully and luxuriously restored in recent years. The outbuildings include a dwelling, an office, a bar, a library, and former stables.

The chateau is located 275 kilometers south of Paris, with the A71 and A20 motorways located nearby.

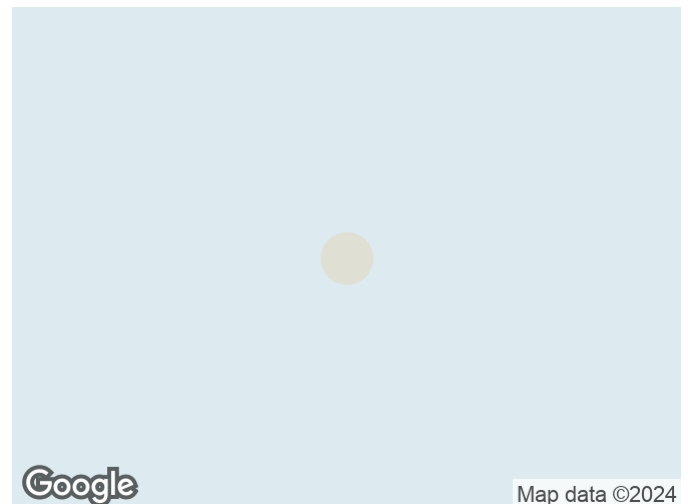
