#### **Property Description**

On the edge of a small, lively village with many attractions, 10 minutes from Condom, this splendid contemporary house comprises 170 m<sup>2</sup> of living space, plus a separate 37 m<sup>2</sup> guest room, a 110 m<sup>2</sup> garage, a lovely garden with a spring and a swimming pool.

The house comprises a large, triple-exposed living room opening onto 2 terraces, with a wood-burning stove and underfloor heating, and an open-plan fitted kitchen. On the same level is the master bedroom with ensuite shower room and dressing room. The lower level comprises the main entrance, a lounge, a bedroom with ensuite shower room and dressing area, the utility room and access to the garage. The chambre d'hôte is accessed from the outside, but access could be recreated through the house if required. It comprises a bedroom, a shower room and a breakfast area. It has its own private terrace.

The 8x4 m above-ground swimming pool benefits from a pleasant poolhouse, new liner, pump and heat pump to heat it.

The 3600 m<sup>2</sup> wooded garden is laid out around large terraces and features a spring and a small pond.

The assets of this modern property: insulation and double glazing, oil-fired heating supplemented by heat pumps, a solar water heater, fibre, mains drainage. Come and see for yourself
