Via the patio door, you enter directly into the 13m² kitchen, equipped with storage units and a sink (no white goods). The living room is 30m². You will appreciate the wooden flooring which adds original charm.

Two bedrooms of 12m² each and a washroom with toilet complete the living areas. You will also have at your disposal a 37m² garage, with insulated roof, attached to the house.

The heating is provided by fuel. All windows are double-glazed. Hot water is provided by a 200 litre electric-powered storage tank. The property is served by a septic tank system up to current regulations at publication.

The land is entirely fenced and accessed by a gate.

You will be 7 mins from Castelnau-Magnoac, 9 mins from Trie-sur-Baïse, 25 mins from Lannemezan, 45 mins from Tarbes, 1h30 from Toulouse, 2h30 from the Atlantic Ocean.
