The renovation is of exceptional quality, highlighting noble materials and ensuring total comfort: underfloor heating on both levels via heat pump, excellent insulation, double glazing, and an unusually strong energy performance rating for a stone property of this size (DPE B/A).

Outside, the heated swimming pool – also powered by a heat pump – is surrounded by a travertine terrace that invites relaxation. Generous shaded terraces offer ideal outdoor living, even on the hottest summer days.

The property is set in peaceful surroundings, with no overlooking neighbors and bordered by open fields inhabited by preserved wildlife – deer, rabbits, birds...


