Superb traditional mansion in the heart of the town in a very quiet street, offering a total surface of about 600 m2 of which about 300 m2 of living space with en suite luxury B&B rooms, a beautiful courtyard, a magnificent vaulted wine tasting cellar and some charming roof terraces. It is an historic property, with an elegant architecture, a unique property sought after for its beauty and central location.

Basement = Wine tasting vaulted cellar of about 35 m2.

2nd = Hall of 4 m2 + large en suite bedroom 3 with a lounge of 20.2 m2 and a bedroom of 13.2 m2 en suite with a bathroom of 5.3 m2 (bath, washbasin, WC) + en suite bedroom 4 of 22 m2 with washroom of 4 m2 (shower, washbasin, WC) and dressing room + terrace of 35 m2 with access to a private courtyard of 17 m2 and en suite bedroom 5 of 23.7 m2 with bathroom of 8 m2 (balneo bath, washbasin, WC).

Extras = Town gas central heating + reversible air conditioning in 4 bedrooms + estimated amount of annual energy consumption for standard use: 2986 Euros per year (including subscriptions) + annual land tax of 4351 Euros + occupation rate of 99 % in full season + in the center of town in a quiet street + parking in front of the house. Price = 1.785.000 Euros (Superb and unique!)


