Village with with all shops, cafes and restaurants, schools, 15 minutes from Beziers, 10 minutes from the Orb river and 10 minutes from the Canal du Midi.

Former annex of a large domain dating from the mid 19th century with 288 m2 of living space on 565 m2 of

land. The home, in the style of a maison de Maitre, has kept all of its original character and offers large rooms and a semi converted former stable. The garden is located at the front and is spacious enough to receive a pool. Rare in the centre of the village !

Ground = Entrance hall of 8.5 m + kitchen of 20.6 m2 + dining room of 16 m2 + lounge/office of 23.5 m2 leading to fomer stable of 57.5 m2 converted into a leisure room + storage room of 10 m2 + washroom of 4.3 m2 (washbasin, WC, washing machine connection) + garage of 100 m2 with electric gate.

1st = Hall of 15.5 m2 + 3 bedrooms of 14 m2, 16 m2 and 17 m2 + WC + bathroom of 11.6 m2 (bath, shower, double washbasin) + storage room of 19.5 m2 + attic of 73 m2 and attic of 56 m2 (above the former stable).

2nd = Hall of 4.4 m2 + bedroom to renovate of 17.7 m2 + 2 bedrooms of 13.6 m2 and 18.2 m2.

Exterior = Nice garden of 240 m2 that could receive a pool.

Extras = 2 central heating systems: a boiler with a heat pump and an oil boiler + annual land tax of $1360 \in$ + some modernisation a a few electric updates to foresee + original tiles under the carpets + estimated amount of annual energy consumption for standard use: between 3419 \in and 4625 \in per year. 
