

#### **Property Description**

A few steps from the port of Nice and the old town, the Riquier district is promising. It is located near major urban projects in the city of Nice: the future extension of the Promenade du Paillon and the ICONIC project.

This rehabilitation program of Nice Center is located at the foot of the future "Coulée Verte", the extension of 8 hectares of greenery, planned for 2025, creating a real green lung in the heart of Nice.

This authentic and warm district is full of assets. Both residential and commercial, the Riquier district mainly attracts families because it is provided with all the amenities (transport, schools, local shops, etc.) allowing a lifestyle "everything on foot". The restaurants and shops make it a very lively district in which life is good.

Located directly at the foot of the future extension of the Promenade du Paillon, this Nice Centre rehabilitation program consists of 4 apartments, 2 of which have a clear view of the upcoming "Coulée Verte". The T2 and T3 type lots are on the 1st and 3rd floors of the building. The exposure of the apartments gives them natural light. They will benefit from a kitchen open to the living room offering a large living area. The properties will be enhanced with modern services in a contemporary style, while respecting the old character of the typical Nice apartment.

The common areas of this rehabilitation program facing the Coulée Verte will be completely rehabilitated. Our teams will keep the beautiful period railings of the stairs, the travertine steps of the stairs and the Belle Epoque style landing doors. Finally, the facade of the building will be renovated while keeping the warm tone, typical of Mediterranean cities and the shutters: wooden blinds.


